

Guide to Choosing a Personal Injury Lawyer

Choosing a Personal Injury Lawyer

If you've slipped, tripped or been involved in an accident, you may be entitled to compensation for the pain, suffering and financial loss that you have experienced. Making a successful claim can be complicated, so your choice of personal injury lawyer is very important.

However, with the vast majority of people looking to claim compensation doing so for the first time, and no shortage of personal injury lawyers available, what criteria should you use when deciding which lawyer is right for you?

There are a few basic things you should look for in the first instance.

Firstly, make sure you choose a firm that specialises in personal injury claims, such as Burton & Dyson, instead of just visiting a high street solicitor. Also make sure the firm has expertise in the specific type of injury you have experienced, especially in motor accident and clinical negligence claims. When you meet with your lawyer, ask if they have recently taken on a similar injury claim and what the result was.

In addition, you should look for a lawyer that is a member of either the Law Society Personal Injury Panel or the Association of Personal Injury Lawyers (APIL). This proves they have the relevant experience and knowledge to handle your claim, and need to comply with APIL's rules and regulations.

You also need to consider personality, so a local firm with a personal service would be best. A compensation claim is a collaborative process between you and your lawyer that requires mutual trust, so you should feel comfortable and secure when discussing your case with them.

Your lawyer should listen to you, and be responsive to any concerns, questions or needs you might have, explaining everything in understandable laymen's terms with no complex jargon or legal language.

Costs and fees, as well as the chances of your case succeeding, should be explained honestly, and there should never be any hidden costs.

Before entering into any kind of formal agreement with a personal injury lawyer, you will have a chance to interview each other at an initial consultation. This gives you a chance to ask about your lawyer's background, experience and costs.

Areas that you should consider asking about include: the overall costs of your case, the fee structure and how often you will be billed, how often you will be informed about progress, how strong your case is and if it could be settled before trial, and, conversely, is there any risk of failure, and, if that happens, what your potential liability will be.
