According to the U.S. Department of Transportation, there were 2,445 fatalities in 2010 linked to alcohol-impaired drivers in Florida. While this is a sobering statistic, the transportation department reports that alcohol-related deaths had declined in 2010 by 4.5 percent. There were 2,560 alcohol-related fatalities in 2009 in Florida, according to the government's data.

While drunk driving has been on the decline for the past several decades, the frequency of DUI fatalities is alarming. Every two minutes, someone is injured due to a drunk driver's actions. Every 30 minutes, a person dies because of someone who was DUI, according to recent studies.
