

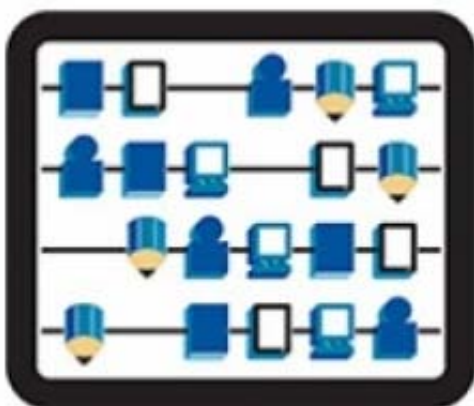

ResultsPlus Direct - Student Access on GCSE/GCE Results Days

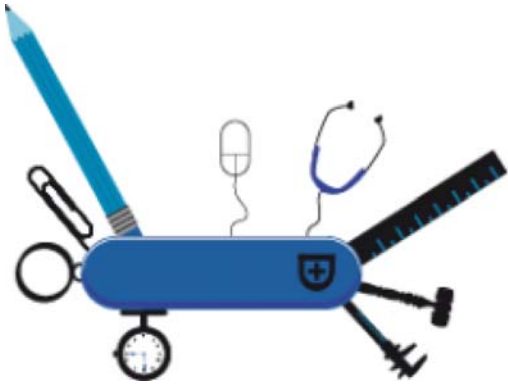
Please note that students will only be able to log onto ResultPlus Direct from 9.00am on both GCE and GCSE August Results Days. Question level analysis will be available the following day.

Uploading Candidate Data

When uploading your candidates' data please ensure that the details match exactly with their entries - otherwise some candidate data may be rejected.

Please ensure that you use our ResultsPlus Direct candidate data template, and not your own spreadsheet, otherwise the system will not recognise the file and reject it. You should also ensure that you do not amend or delete any of the columns on the template.

GCSE Unit Results - August 2014

Although the GCSE qualification has changed to a linear structure from this year, we can confirm that we will still be issuing GCSE unit results along with the overall awards as usual this summer.



BTEC Bulk Claims Reporting - Edexcel Online Issue

An issue has been identified regarding the new Edexcel Online BTEC bulk claims functionality which allows you to claim certification for more than one of your learners at the same time. It is not currently possible for you to save forms to return to them later. If you click 'Save without claiming and continue later' all data will be lost.

We apologise for the inconvenience, and are working to resolve the issue as soon as possible.

NB: there is a 30 minute period on Edexcel Online before the system times out, so please complete your claims and click 'Confirm grades and make claims' within this period.



New Entry Dates for 2014/2015

Following JCQ guidelines to change the June 2015 examination session entry deadline to **21 February 2015**. This means that all GCSE, International GCSE, GCE, PLSC and CiDA entries for summer 2015 series should be submitted by this date. Any entry received after the entry deadline may incur a late fee. Please see below for the other associated dates:

Entry Deadline 21 February 2015
 Amendment deadline 21 April 2015
 High Late Fee 22 April 2015

The Entry deadline for IAL will continue to be on the 21st March 2015. Please note the amendment and high late fee dates are specific to each Awarding Organisation.
