Program of Instruction Course Syllabus

Course Title: ICS Overview for Executives/Senior Officials (ICS-402)

Course Duration: 4 hours

Program: NIMS

Course Prerequisites: None

Course Description: The purpose of this four hour course is to provide an orientation to the Incident Command System (ICS) for Executives and Senior Officials (including elected officials, city/county managers, agency administrators, etc.). Upon successful completion of this course, the student will have an increased level of understanding of NIMS, the Incident Command System, and how it applies and effects their jurisdictions.

Course Requirements and/or Recommendations: These can be divided into three categories: those completed prior to arriving in class (Pre-Course Work), those completed during class, such as homework assignments and quizzes (Course Work), and requirements completed after class but prior to receiving a certificate of completion. (Post-Course Work)
