

# BREXIT and Continued UK Participation in EU Programmes for Research, Innovation and Higher Education

UKRO maintains this factsheet to provide the latest information on the current UK situation in relation to Horizon 2020 and other EU funding schemes. You are invited to disseminate this factsheet within your institutions and to your European and international partners.

#### **UK participation in Horizon 2020**

The UK and the EU have agreed a flexible extension to the of the Article 50 period for six months to 31 October 2019. During the extension period the UK will remain a member of the EU with all the relevant rights and obligations. This means that UK organisations can continue to participate in Horizon 2020 as a Member State, and remain eligible to apply for Horizon 2020 funding. This includes requesting the relevant part of the project's budget as an EU contribution. A ratified deal, based on the provisions set out in the <u>Withdrawal Agreement</u>, would ensure continued UK participation in Horizon 2020 until the end of the programme and for the lifetime of projects. If the Withdrawal Agreement is ratified by the UK Parliament before 31 October, the extension would be terminated, and the UK would withdraw from the EU on the first day of the following month. The government's no deal guarantees remain in place to ensure continuity of funding in a no-deal scenario.

## Withdrawal Agreement

A ratified deal, based on the provisions set out in the <u>Withdrawal</u> <u>Agreement</u>, would ensure continued UK participation in Horizon 2020 until the end of the programme and for the lifetime of projects.

If an agreement is reached, projects approved during this period will be able to continue with an uninterrupted flow of EU funding.

#### Submitted Before UK Exit

The UK government has <u>committed to underwrite</u> competitive UK bids to EU funding submitted before exit, even if they are notified of their success after exit, for the lifetime of the projects.

This will cover the funding for UK participants in Horizon 2020 projects in nodeal scenario.

## Guarantees to ensure continuity of funding in a no-deal scenario

#### **Submitted After UK Exit**

The UK government <u>Post EU Exit Guarantee Extension</u> would cover funding for successful UK bids to EU calls open to third country participants from the date of exit until end of 2020.

The guarantee would cover the lifetime of their projects, even if these last beyond 2020.

The government is seeking discussions with the European Commission to agree the details of the UK's continued participation as a third country.

The UK government provides official information about UK participation in Horizon 2020 in a technical notice 'Horizon 2020 funding if there's no Brexit deal' and a dedicated Q&A document.

## What has been done to prepare for no-deal Brexit in Horizon 2020?

<u>UK Research and Innovation</u> (UKRI) has been appointed to manage the UK government's guarantee and post-EU exit extension. UK beneficiaries of Horizon 2020 funding should continue to log details of their on-



going grants on the <u>UKRI Portal</u>. UKRI will keep these details on file and would contact UK beneficiaries in the event that the guarantee would need to come into effect.

#### What does the European Commission say?

**Evaluation** - The Commission provides a <u>briefing for evaluators</u>, which states the following: "... Experts should not evaluate proposals with UK participants any differently than before."

**Addressing Brexit risk in applications** - The Commission also provides **guidance to coordinators** of Horizon 2020 proposals with regards to addressing the risks associated with Brexit in future proposals.

**Eligibility of UK applicants** – The Commission included a notice in the <u>introduction to the 2018-2020</u> <u>Work Programme</u> of Horizon 2020 regarding the eligibility of UK organisations.

**No-deal Contingency Action Plan** - The Commission maintains a <u>website</u> with details of its own no-deal contingency planning, which includes dedicated Brexit preparedness notices for specific sectors, legislative initiatives and other relevant acts.

#### Do you have concerns over including UK partners in Horizon 2020?

The UK Department for Business, Energy and Industrial Strategy (BEIS) maintains a special inbox (<u>research@beis.gov.uk</u>) for queries and to report issues. Researchers and research organisations from outside the UK can contact the inbox in the same way that UK entities can.

## What about UK participation in other EU programmes?

The government maintains a <u>list of technical notices</u> with official information on how to prepare for nodeal Brexit when participating in Erasmus+, LIFE and other EU programmes. The list also provides contact details of relevant government departments in charge of implementing the Guarantee for specific programmes. In March 2019, the government published an <u>overview of the UK's relationship with the EU Research Fund for Coal and Steel</u> (RFCS), together with a set of dedicated FAQs.
