Guidelines for admission to vacant seats in 2nd Year (3rd Semester) in degree level engineering, technology, architecture and pharmacy courses through Decentralized Counseling process under Lateral Entry Scheme of AICTE for the academic year 2017-18.

Whereas, the West Bengal Joint Entrance Examinations Board (WBJEEB), vide Notification No. WB/RegCN-025/17 dated 18.08.2017 has already published the necessary Guidelines for admission to 2nd Year (3rd Semester) of under graduate degree level Engineering & Technology programmes in the academic year 2017-18 through the State Common Entrance Examination for the said programme (i.e. JELET-2017).

And

Whereas, in the said Guidelines the West Bengal Joint Entrance Examinations Board (WBJEEB) has already notified necessary venue, period of counseling, application procedure, counseling fee, eligibility criteria, reservation policy as well as other relevant information towards admission –in 2nd Year (3rd Semester) of under graduate level Engineering & Technology programmes in the academic year 2017-18.

And

Whereas in the said guidelines it has been mentioned that candidates will be required to take admission to the allotted University / Institutes within five days from the date of allotment.

And

Whereas it has been observed that a reasonable number of seats in the second year level are still vacant after the completion of such allotment and admission process in different participating Universities and Institutes of the State offering under graduate level Engineering & Technology programmes.

And

Now, therefore it is clarified that on completion of the centralized counseling and admission process, it has been decided by the State Govt. in the Higher Education Department to allow all the participating Universities and Institutes of the State for admission of students through de-centralized counseling and allotment process in strict compliance with the norms and guidelines as stated below:

Norms and Guidelines for admission to vacant seats in 2nd year (3rd semester) in degree level engineering / technology / architecture / pharmacy courses through De-Centralized counseling and allotment process in 2017-18:

- 1.0 The seats remaining vacant in the second year level will be open for admission through decentralized counseling for the students of diploma holder in Engineering & Technology programmes as well as B.Sc passed following the same guidelines in terms of eligibility criterion for different Universities and Institutes.
- 2.0 The participating Universities and Institutes willing to admit students through such decentralized counseling process shall have to follow a complete transparent admission procedure by inviting application from the diploma holder students in Engineering & Technology progr:ammes from AICTE approved Institutions and B.Sc. passed students from UGC Recognized institutions by posting necessary notice with discipline wise vacancy position in their respective Notice Board and/or the Institutional website.
- 3.0 The candidates will be offered the said vacant seats in the following order of preference:
- Candidates with JELE'T-2017 Rank who are otherwise eligible for admission to 2nd year of Under Graduate level programmes in Engineering & Technology courses as per the Norms and Guidelines provided by the AICTE will be given the first preference. Admission must be made strictly on merit and preference.
- 3.2 Candidates with diploma in Engineering & Technology from AICTE approved institutions who are otherwise eligible for admission under the scheme, will be given the second preference.
- 3.3 Candidates with B.Sc. degree from UGC Recognized Institutions who are otherwise eligible for admission under the scheme, will be given the next preference.
- 4.0 For the candidates under the category 3.1 and 3.2 the list of equivalent disciplines as given hereunder has to be followed:
- 4.1 Degree Level Engineering and Technology courses (including Pharmacy) and the relevant Diploma Programmes from where admission can be sought under Lateral Entry Scheme are given below:

- As per approved Calcutta University Regulation of B.Tech. in Jute & Fibre Course of Calcutta University, it is mentioned that for Lateral Entry admission to 2nd Year (3rd Semester) of B.Tech. in Jute Technology Course of Calcutta University, candidates with Diploma in Mechanical Engineering or Electrical Engineering or Chemical Engineering or Computer Engineering or Electronics Engineering or Textile Technology or Textile (Handloom Technology) or Apparel/Fashion Technology or Passed B.Sc. 2-Year P.G. Diploma in Jute Technology/Jute Technology and Management or B.Sc. in Textiles and Clothing Science or Bachelor of Fashion Design or B.Sc. (with Physics, Chemistry and Mathematics) from any Institute/College or equivalent as recognized by the University of Calcutta and qualified through Joint Entrance Examination for Lateral Entry (JELET) Examination conducted by the West Bengal Joint Entrance Examinations Board will be eligible.
- The cut-off date for completion of the decentralized counseling and admission under this scheme shall have to be in accordance to the academic calendar of the affiliating University concerned for the academic year 2017-18.

- Individual University/institution admitting students under this scheme must maintain complete 6.0 transparency in the admission procedure and accordingly shall communicate the following information positively to the affiliating University:
 - Notice Published. (a)
 - Vacancy List published in a course-wise manner. (b)
 - Merit List prepared for admission from amongst applicant students. (c)
 - The final list of students admitted. (d)
