Why is IDEX's theory of change unusual?

A theory of change provides a conceptual explanation of how an organization expects to reach a commonly-understood long-term goal.

But what if your organization sees the world differently? What if a series of if/then statements that represent a desired social change doesn't work for your organization? What if you're trying to flip philanthropy on its head?

Many foundations and aid agencies see their role as "special forces" of poverty reduction. They sweep into a troubled area, introduce programs, distribute aid, implement quickly, get quick results, and sweep out: mission accomplished. A project-based, interventionist approach lends itself well to the conceptual clarity of a traditional theory of change.

Who doesn't want to be more precise about how an organization's resources will add up to their ultimate goal?

But as more and more organizations come to address the deep roots of <u>social and systemic injustice</u>, they understand how social changes unfold over time. The mapping of complex changes within larger systems – with such varied actors, related factors, and moving parts – is simply not linear.

Why and how did IDEX create a non-linear theory of change?

In 2013, IDEX embarked with its partners on a journey to develop a <u>theory of change</u> that adequately described <u>our strategies</u> to enable people to be agents of long-term, sustainable change in their own societies – to affect their own conditions – which we see as fundamental to transformational social change. Like all organizations, we wanted to help our partners and supporters (and our team!) better understand and represent how we are contributing to the changes we want to see in the world.

Rooted in three decades of experience in human rights, culturally-competent grantmaking, and authentic relationships with <u>grantees</u> in the Global South, the result of IDEX's consultative process is an <u>eye-catching infographic</u> (see link, which is interactive, or next page for the PDF). It allows our grassroots grantees, and IDEX itself, to evaluate the progress we are making towards building democratic, equitable, and environmentally-sustainable <u>solutions</u> to the world's most pressing challenges.




With enough support and resources, women, indigenous people, and youth are proven and powerful agents for lasting, transformative change.

THE COOLEST CITY YOU'VE NEVER SEEN

Tourists flock to Durban, South Africa, drawn to its reputation as a natural paradise with a coastline of sun-kissed beaches and subtropical climate. Dubbed "the coolest city you've never seen" by CNN in 2014, the metropolitan city has a population of over three million.

But paradise may be the last word many of the 300,000 residents of South Durban would use to describe where they live.

As Durban's industrial hub, South Durban houses more than 300 oil and gas refineries, paper mills, landfill sites and more. The area's low-income people live the midst of an industrial nightmare that has led to high rates of cancer, asthma, bronchitis and other respiratory illnesses. For these residents, South Durban is known as "cancer alley" and the toxic capital of South Africa.

Against this backdrop, IDEX partner <u>South Durban Community</u> <u>Environmental Alliance (SDCEA)</u> mobilizes residents to push for an end to industrial pollution. Not content to allow the companies operating in their backyards to go unchecked, residents of 16 South Durban communities formed a coalition in 1995, and SDCEA was launched.

In the two decades since, SDCEA has worked to inform and empower residents to address environmental injustices by monitoring air quality, conducting research, and directly lobbying large companies and government agencies to adopt specific changes. SDCEA's "bucket brigade" is a low-tech, high-impact tool that enables community members to collect air samples and identify pollutants.

SDCEA's 20 years of relentless advocacy have led to many wins for the people of South Durban. One early victory came in 2004, when research and advocacy spearheaded by SDCEA on air pollution and related illness in the area led to a <u>new law that established national air quality and emissions standards</u> for South Africa.

In another big victory, SDCEA helped shut down a landfill operated by Wasteman, a large waste management company. Started without community input in 1991, the landfill had been used for 21 years to dump hazardous waste that poisoned the air, contaminated the groundwater and seeped into the soil.

In 2009, when Wasteman applied to expand the lease on the landfill until 2021, SDCEA seized the opportunity to start a campaign to close the landfill for good. Under the leadership of its co-founder, Desmond D'Sa, SDCEA used innovative methods to organize residents. Community members spoke out at public hearings, and SDCEA's high profile demonstrations got consistent coverage in the media. As a result, Wasteman withdrew its plans to expand and the landfill closed down in 2011. D'Sa was awarded the Goldman Environmental prize in recognition of his brave work.



Now, SDCEA is in the midst of another important fight. Petrochemical conglomerates are pushing a \$25 million "Dig-Out Port" expansion project that will wreak untold havoc on the surrounding communities' ecology, economy, and safety. Among the goals of the expansion: to double the city's oil refining capacity and increase the traffic of shipping containers from 2.5 million per year to 20 million by 2040. The project threatens the homes, health and livelihood of thousands.

SDCEA has joined other environmental groups to <u>stop the Durban port expansion</u> from moving forward, calling global attention to the displacement, job loss, and ecological damage it will cause.

Paradise must mean a healthy and prosperous Durban for all.
