# SQF Code Change Map: 5<sup>th</sup>/6<sup>th</sup> Editions into 7<sup>th</sup> Edition

### Introduction:

The issuance of a  $6^{th}$  edition of the GFSI Guidance Document in January 2011 presented the SQF Institute with an opportunity to review the SQF 1000 and 2000 codes and revise them as necessary. Ultimately, the SQF 1000 and 2000 Codes were combined into one Code and includes modules for all industry scopes identified in the  $6^{th}$  edition of the GFSI Guidance document.

The 7<sup>th</sup> edition of the SQF Code has been re-numbered to accommodate the realignment of the code. Allergen management, approved suppliers and training has been added to the system requirements that are now in module 2 and the elements for site requirements and pre-requisite programs have been combined into the relevant industry module. A map between modules 2, 7 and 11 and their corresponding 1000 and 2000 element numbers is outlined here.
