Learning Outcomes:

Applicants applying for admission onto a RCSI Institute of Leadership MSc programme as part of the RPL

(Type 1) entry process must demonstrate the following:

- have the ability to gather and interpret relevant data (usually within their field of study) to inform judgements that include reflection on relevant social, scientific or ethical issues;
- can communicate information, ideas, problems and solutions to both specialist and non-specialist audiences;
- have developed those learning skills that are necessary for them to continue to undertake further study with a high degree of autonomy.
