



SUFFOLK COUNTY SHELLFISH AQUACULTURE LEASE PROGRAM LEASEHOLDER ANNUAL REPORT FORM

All leaseholders must report their shellfish farming activities to the County on an annual basis. Each Leaseholder is required to submit a Leaseholder Annual Report to the Division of Planning & Environment each year that they retain their lease with the County. All aquaculture activities that were conducted during the period of _____ to _____ should be reported on this form; if no activities were undertaken this year, indicate the same on this form. If permit modifications have been applied for and/or made to alter your cultivation activities (type of culture, species cultivated, gear type), please notify the County of the same on this report and submit copies of current permits. This annual report should also include information regarding activities conducted on any sublease involving the leased premise.

This form, along with the annual lease rental fee and SC Form 22, is due 30 days before the lease anniversary date. Leaseholders are also required to submit this report 30 days before the termination or expiration of a lease and prior to the application for a lease renewal, assignment or sublease.

Please note sections of the Leaseholder Annual Report Form requests information pertaining to your aquaculture gear and product distribution. Your individual information will not be made public and will only be used collectively to summarize the economic impacts of this program.

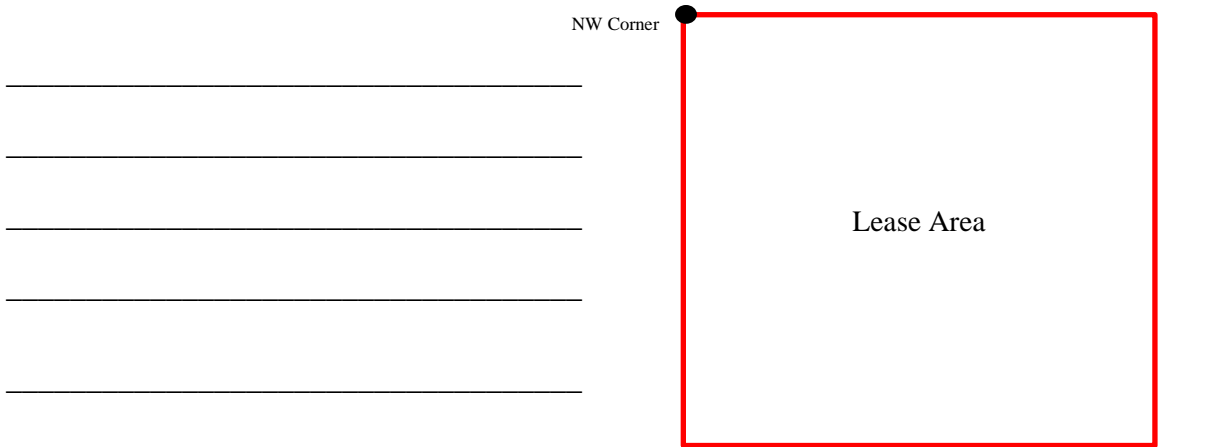
