- 1) B.A.LL.B.(Hons.) Degree Course

#### Intake

The number of students to be admitted in each of the integrated Degree Course shall be 156\* (inclusive of NRI). All efforts will be taken to pay individual attention on every student.

\*As per G.O.Ms.No.418 Law (LS) Department dated 30.07.2012, on the basis of merit list, 4% of the total seats have been allotted to the Higher Secondary Courses (+2) Vocational Stream Candidates.

## Non-Resident Indians (NRI) Quota

Of the total number of seats 15% has been earmarked for NR1candidates. Unfilled NRI seats will be converted to general and filled as per merit.

## Eligible Qualification

A candidate should have passed **Higher Secondary Examination (10+2) OR its equivalent examination** recognized by the Tamil Nadu Dr. Ambedkar Law University, Chennai and should have secured not less than **70**% of the total marks in the aggregate of all the subjects.

The candidates belonging to Scheduled Caste/Scheduled Tribe communities should have secured not less than 60% of the total marks in the aggregate of all the subjects.

NRI Candidates, who make a claim under the Non-Resident Indians (NRI) category, should have secured not less than **70**% in the qualifying examination.

Candidates aspiring to apply for **B.Com.LL.B.[Hons.]** must have studied **Commerce** and those **B.C.A.LL.B.[Hons.]** must have studied **Computer Science** as a subject in the Higher Secondary Examination.

Separate application forms should be submitted for each Course. Candidates applying for **B.A.LL.B** (Hons.) and **B.B.A.LL.B** (Hons.) can use the same application form.

## **Eligible Qualification**

A Candidate should have passed **Higher Secondary Examination (10+2) OR its equivalent examination** recognized by the Tamil Nadu Dr. Ambedkar Law University, Chennai and should have secured not less than **45**% of the total marks in the aggregate of all the subjects.

The Candidates belonging to Scheduled Caste/Scheduled Tribe communities should have secured not less than 40% of the total marks in the aggregate of all the subjects.

**NOTE:** a) Candidates can apply through online mode only, for which applicants have to pay application processing fee through online payment gateway only.

- b) Application Processing Fee paid through other modes, by Cash/Demand Draft / Money Order/Cheque/Bank Pay Order Challan etc., will not be accepted. Fee once paid will not be refunded.
- c) Selection for admission will be conducted only through online. Candidates will be selected purely on merit based on their performance in the qualifying examination and strictly as per the rules of reservation prescribed by the Government of Tamil Nadu.
