Bruce-

I'm sounding the alarm.

The parking deck located at 6th and Scott needs immediate help from LRPD to secure it and deter the people up to no good from using the deck as their personal toilet and drug haven. In recent weeks the complaints are coming in daily and at an increasing number. In my 6 years here I have never seen it at the fever pitch that currently exists. State employees are quitting their jobs or opting to pay for parking somewhere else due to them not feeling safe to park. I have had three calls today alone about

incidents in the deck. That in addition to the calls yesterday and on Sunday from the Rep.

We have previously alerted LRPD to this issue on multiple occasions. The behavior at the deck has become even worse.

We have temporarily hired private security for the early morning hours to deter folks from being in there at the start of business. They are routinely running people off, but now the problem is escalating during the daytime hours. This is more than our single ambassador can manage.

We need help to address this ASAP.

I spoke to Lt. Miller today and have passed on the contact info of the downtown Sgts to the folks in the Main Street mall, so that they can be contacted immediately.

Please let me know how I can help facilitate this.
