ORDINANCE NO. 1328

AN ORDINANCE AMENDING CHAPTER 150, MOTOR VEHICLES AND TRAFFIC, ARTICLE III, PARKING REGULATIONS, OF THE EAST STROUDSBURG BOROUGH CODE OF ORDINANCES.

BE IT ORDAINED by the Borough Council of the Borough of East Stroudsburg that Chapter 150, Article III of the East Stroudsburg Code of Ordinances is hereby amended to include as follows:

§150-23.2. Parked Against the Flow of Traffic.

- A. Except as may otherwise be provided in this Chapter, every vehicle standing or parked upon a two-way highway shall be positioned parallel to and with the right-hand wheels within 12 inches of the right-hand curb or, in the absence of a curb, as close as practical to the right edge of the right-hand shoulder.
- B. Except as may otherwise be provided in this Chapter, every vehicle standing or parked upon a one-way highway shall be positioned parallel to the curb or edge of the highway in the direction of authorized traffic movement with its right-hand wheels within 12 inches of the right-hand curb or, in the absence of a curb, as close as practical to the right edge of the right-hand shoulder, or with its left-hand wheels within 12 inches of the left-hand curb or, in the absence of a curb, as close as practical to the left edge of the left shoulder.

§150-23.3. Double Parking.

Except when necessary to avoid conflict with other traffic or to protect the safety of any person or vehicle or in compliance with law or the directions of a police officer or official traffic control device, no person shall stop, stand or park a vehicle on the roadway side of any vehicle stopped or parked at the edge or curb of a street.

§150-23.4. Parking on a Sidewalk.

Except when necessary to avoid conflict with other traffic or to protect the safety of any person or vehicle or in compliance with law or the directions of a police officer or official traffic control device, no person shall stop, stand or park a vehicle on a sidewalk.

§150-23.5. Blocking a Driveway

Except when necessary to avoid conflict with other traffic or to protect the safety of any person or vehicle or in compliance with law or the directions of a police officer or official traffic control device, no person shall stand or park a vehicle in front of a public or private driveway.

§150-23.6. Fire Hydrant

Except when necessary to avoid conflict with other traffic or to protect the safety of any person or vehicle or in compliance with law or the directions of a police officer or official traffic control device, no person shall stand or park a vehicle within 15 feet of a fire hydrant.

§150-23.7. Private Property

No person shall park or leave unattended a vehicle on private property without the consent of the owner or other person in control or possession of the property except in the case of emergency or disablement of the vehicle, in which case the operator shall arrange for the removal of the vehicle as soon as possible. The provisions of this section shall not apply to private parking lots unless such lots are posted to notify the public of any parking restrictions and the operator of the vehicle violates such posted restrictions. For the purposes of this section, "private parking lot" means a parking lot open to the public or used for parking without charge; or a parking lot used for parking with charge.

Repealer

Any portions of Borough ordinances or resolutions which are clearly in direct conflict in regards to the same matter with this Amendment are hereby repealed.


Severability.

It is hereby declared to be the legislative intent that if a court of competent jurisdiction declares any provisions of this Amendment to be invalid or ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Amendment shall continue to be separately and fully effective. The Borough Council hereby declares that it would have passed this Amendment and each section or part thereof, other than any part declared invalid, if it had advance knowledge that any part would be declared invalid.
