

UCLA is committed to providing a fair process for both complainants and respondents involved in sexual misconduct cases. We understand that respondents may have questions or concerns about the University's processes, and may want to access additional resources. Respondent Support Services are available at the Office of the Dean of Students to provide assistance. These services include guidance & coordination with the student conduct process, as well as referrals to available campus and community resources. What is Respondent Support Services?

1. Respondent Support Services can help a Respondent navigate the UCLA student conduct process, up to and including the hearing and review process. A Respondent Support Services provider is available to serve as the respondent's "Campus Assistant" at Student Conduct Committee hearings.
2. Support services include:
 - a. Review of rights and the University Student Conduct Procedures.
 - b. Guidance and support through the process.
 - c. Presence at meetings with the Title IX officer, the conduct dean, and the conduct hearings.
 - d. Assistance with logistical issues related to interim suspensions or other restrictions of privileges.
 - e. Connection to campus resources.

The Respondent Support Services staff is not:

1. An advocate on behalf of the respondent.
2. A confidential resource.
3. A provider of legal advice.
4. An investigator or adjudicator in the student conduct process.
