Personal Crisis	<ol> <li>A detailed explanation of the crisis including the date of occurrence, duration, and how it negatively affected your coursework.</li> <li>Support documentation (i.e. physician's statement, copy of police report, Personal Protection Order, medical documentation)</li> <li>Support documentation regarding what steps you've taken to resolve the crisis and successfully move forward (i.e. physician's statement, academic adviser, 3<sup>rd</sup> party agency that assisted you with resolving this crisis).</li> </ol>
Death of a Family Member/ Roommate/Close Friend	<ol> <li>A detailed statement including the name of the deceased and his/her relationship to you with an explanation of how this event negatively affected your coursework.</li> <li>Support documentation (i.e. copy of the obituary, notice of the funeral, or death certificate).</li> <li>Support documentation that demonstrates your ability to return to classes and successfully complete your course load (i.e. statement from academic adviser, letter of support from Counseling and Wellness Services, physician statement).</li> </ol>
