Petition for Childbirth Accommodation Funding for Women Doctoral Students

Women doctoral students in good academic standing who hold a fellowship or Graduate Student Instructor (GSI) or Graduate Student Researcher (GSR) appointment, and who expect to give birth shall be eligible to receive up to six (6) weeks of paid leave for pregnancy, childbirth, or related medical conditions for the period prior to, during, and after childbirth.
