# **Style Sheet: Guide for Authors**

Please follow the guidelines given here when submitting or revising your article for publication. The editors reserve the right to make editorial revisions in articles and reviews.

### General

• Please submit all manuscripts for consideration by means of our web-based submission system, Scholar One: http://mc04.manuscriptcentral.com/jhi If for some reason you are unable to do so, please contact the editorial office.

• Submitted articles may not exceed 9,000 words in length, including endnotes. Submissions that exceed 9,000 words will not be accepted for review. Please check your word count before submitting: in Microsoft Word, go to the Tools Menu, click "Word Count," and be sure that you have checked the box near the bottom beside "Include footnotes and endnotes."

• The vast majority of articles published in the *JHI* sustain an argument for a minimum of 5,000 words. Shorter submissions will generally not be considered, with very rare exceptions for specific research notes.

• Normally the *JHI* will not consider for publication articles previously published elsewhere, whether in print or online. Articles made available via university-sponsored open-access repositories are considered published.

• Please eliminate all identifying information from your manuscript, in order to facilitate blind peer review. If you must include references to your own work, avoid using the first person in connection with it.

• Formatting your file:

- Please submit your file as a Microsoft Word document (doc or docx).
- Please check to be sure that your file does not have visible editorial markups; that is, if you have edited your file with "track changes" or if you have made comments, be sure to remove those markings before submitting your file.
- Please do no not "lock" your file. The conversion to PDF will prevent tampering.
- Formatting your document:
  - Lines should be double-spaced, including quotations and endnotes, using Times New Roman font in 12-point size.
  - Left-align all text (do not justify). Use 1" or 2.54 cm margins all around, i.e. top and bottom as well as right and left. Set paper size to US letter (8.5" x 11" or 21.59 cm x 27.94 cm).

- Place page numbers on each page in the top right corner.
- Endnotes should be numbered consecutively and double-spaced. In reviews of books, there should be no endnotes, all material being incorporated into the text.
- Endnotes should be used for citation purposes only and should not contain any discussion that cannot be incorporated into the text of the article.
- Place all periods and commas within quotation marks; other punctuation should be included within quotation marks only if it is part of the quotation cited.
- Long-format quotations should be free of external quotation marks and indented flush-left 0.5" (1.27 cm).
- Inclusive page numbers and dates should be typed according to the following examples: 3–17, 23–26, 100–103, 104–7, 124–28, 1002–6, 1115–20, 1496–1504.
- Spelling, punctuation, use of decimals, and other conventions should follow American standards.

#### Images

Authors are expected to obtain permission to reproduce any copyrighted materials (e.g. photographs) used in their articles. Please submit image files as 300-dpi TIFs. ScholarOne will accept all your files in series. Supply a list of figures and/or tables, including a caption for each, accompanied by a source line and such acknowledgments as are required. If you are unable to submit TIFs, please contact the editorial office.
Figures and/or tables should only be indicated with textual placeholders in the manuscript. Upload the corresponding files separately in ScholarOne, properly labeling each using the drop-down menus provided.

#### Quotations in foreign languages

• Single words or short phrases, where essential to the argument, may be left in the original language; all quotations should appear in the body of the text in English.

• The text in its original language should appear in the endnotes whenever practical.

• In cases where standard scholarly translations of quoted texts are available, scholars may rely upon them for both text and endnotes according to the professional standards of their fields of specialization. If such editions are not widely and readily available, and the author has not provided the original text in the endnotes, the author must provide the original texts in an appendix for the reviewers' use.

• If an article contains extensive blocks of special characters in a non-Latin alphabet, authors need to submit the complete blocks as image files, not in text format.

# Citations

• The *JHI* generally follows the current edition of *The Chicago Manual of Style*, "Chicago A." Endnotes may be used for citation purposes only. Endnotes may not include any discussion or argumentation. Endnotes may contain quotations in the original language. The following basic citation examples apply for the first full reference; subsequent references should be shortened to author, short title, and page numbers.

#### Book:

Richard S. Westfall, *Never at Rest: A Biography of Isaac Newton* (Cambridge: Cambridge University Press, 1980), 200–211.



#### Translated book:

Lucien Febvre, *The Problem of Unbelief in the Sixteenth Century: The Religion of Rabelais*, trans. Beatrice Gottlieb (Cambridge, Mass.: Harvard University Press, 1982), 126–27.

#### Article from a collection of essays:

Peter Burke, "Tacitism," in *Tacitus*, ed. T. A. Dorey (London: Routledge & Kegan Paul, 1969), 149–71.

#### Book (part of a multi-volume work):

Charles E. Trinkaus, In Our Image and Likeness: Humanity and Divinity in Italian Humanist Thought (Chicago: University of Chicago Press, 1970), 2:801.

#### Journal article:

Robert Darnton, "In Search of Enlightenment," *Journal of Modern History* 43 (1971): 113–32.

• The published works of many authors have standard critical or scholarly editions, and some have similarly standard English translations. For any author or text treated or discussed in a substantial manner, please use these editions when they exist. If you quote a translation in the body of the article, the reference should include a citation to that passage in the original-language edition as well. If there is no English translation and the translation in the body of the article is yours, it is preferable to quote in your endnotes the text in the original as well as providing for reference.

#### **Classical references**

• The edition, as well as credit for translation, must be specified the first time a work is cited. You should use standard scholarly editions and translations when they exist for the work in question unless your argument requires otherwise.

• References to information supplied by a modern editor must include page numbers.

• References to the classical text must include the standard identification numbers for that text, such as book and chapter numbers or Stephanus numbers. Use Arabic numbers for all divisions.

- Plato *Republic* 360E–361B.
- Cicero *De officiis* 1.133.
- Standard abbreviations may be used.

# Submission of final draft for publication

• If your manuscript is accepted for publication, you will be asked to submit a finalized article manuscript with all images as needed. Delays at this stage may affect publication date. To avoid delays in the production of the journal, proofs will be sent to contributors on a strict schedule, usually in electronic format (PDF). Any amendments or corrections should be sent to the editors electronically as soon as possible after receipt of proofs. If a contributor's corrections have not been received on time, the editors will take responsibility for checking, correcting and passing along all proofs for press. The journal reserves the right to charge authors for any excessive amendments to the material at proof stage.



# Copyright and permissions

• It is a condition of publication in the journal that authors grant an exclusive license to the Journal of the History of Ideas, Inc. Authors will be provided with a copyright transfer agreement that must be signed and returned prior to the publication of any work in the journal. It is the author's responsibility to obtain print **and** online permission to quote material from third-party sources and to cover any costs incurred in securing these rights. The editors should be alerted at the earliest opportunity as to any difficulty in securing these third-party rights.

• As part of the license agreement, authors may use their own material in other publications provided that the journal is acknowledged as the original place of publication, and the publisher, the University of Pennsylvania Press, is **notified in writing and in advance**.

• The publisher will supply the author of an article with 2 copies of the issue in which his or her work is published. Offprints may be ordered at discounted cost at the time of page-proof review.
