Submission Information:

Author Guidelines

To submit an article, please visit <http://www.editorialmanager.com/jip> and create an author profile. The online system will guide you through the steps to upload your article for submission to the editorial office.

The *Journal of Information Policy* uses the most recent edition of the *Chicago Manual of Style* for word choice, mechanics, and paper structure. For citations, please use that style's Notes and Bibliography documentation system (not Author-Date), which requires footnotes and a full bibliography. The article must conform to the guidelines of this style to be considered for publication.

The article must be submitted in the form of a Microsoft Word compatible file. Please use double spacing and 12-point font Times New Roman.

To ensure the success of the blind review process, please submit both a blind version of your article and a cover page document with all author information. Please upload these as separate documents following the guidelines provided on the submission page on <http://www.editorialmanager.com/jip>.

For the blind version of the article, do not include the author's name(s) anywhere in the document. Also, remove internal self-citations (such as "in 2008 I argued...") by which the reviewer may discern the author's identity. Be sure to erase all identifiers from the "summary" and "statistics" sections of the document preferences as well.

The cover page document should include the name and affiliation of each author, along with the article title.

The article may include charts, graphs, and other illustrations that advance the author's arguments and enhance the reader's understanding. These items should not be embedded in the Microsoft Word file but as separate files following the guidelines provided on the submission page on <http://www.editorialmanager.com/jip>. Appendices, when necessary, should be uploaded separate files as well.

Authors are requested to provide a 100 word introductory statement to their paper, which will come instead of the traditional abstract. We propose you prepare a summary that first states the policy question addressed, followed by a brief statement of the finding or conclusion, with at most two or

three sentences of elaboration. In preparing this introduction please be advised that the audience for the articles in the JIP consists of both policy makers and academics, hence the purpose of this summary is to enable the policy makers decide quickly whether or not the article is relevant to their interests. At the same time this introduction should enable search engines to identify your paper as relevant, so do use in it and in your title the keywords that best categorize your paper.

Authors are encouraged to obtain the appropriate permissions for materials originally produced by others. Permissions are not required if the usage of such materials falls within the legal boundaries of Fair Use. Regardless, obtaining proper permissions is the responsibility of the author(s).

Submission Preparation Checklist

As part of the submission process, authors are required to check off their submission's compliance with all of the following items, and submissions may be returned to authors that do not adhere to these guidelines.

1. The submission has not been previously published or currently under review at a different journal.
2. The file is in Microsoft Word format (.doc or .docx file type). All illustrations (charts, graphs, photos, tables, etc.) are not embedded within the same file, but uploaded as separate documents.
3. The name and affiliation of the author(s), as well as internal citations, have been removed from the primary article document, including the summary and statistics in the document "preferences."
4. A cover page containing the name and affiliation of the author(s) has been uploaded separately.
5. All URLs referenced in footnotes are reproduced fully (starting with "http") and represent active websites. Include the date of access for each URL. If a URL is currently inactive, add an explanation to the footnote.
6. The text is double-spaced and in 12-point font. Footnotes can be in 10-point font.
7. The citations (footnotes and bibliography), word choice, mechanics, and paper structure conform to the most recent edition of the Chicago Manual of Style.

Authors who publish with this journal agree to the following terms:

1. Authors retain copyright and grant the journal right of first publication with the work simultaneously licensed under a Creative Commons Attribution License that allows others to share the work with an acknowledgment of the work's authorship and initial publication in this journal.

The names and email addresses entered in this journal site will be used exclusively for the stated purposes of this journal and will not be made available for any other purpose or to any other party.

Review Policy

All **original articles** are initially reviewed by the Journal's editors, who will assign two to three peer reviewers unless the manuscript is inappropriate in topic or quality, outside the scope of the Journal, or not sufficiently timely or original. All submitted articles must be the author's unique work and

must not have been previously published elsewhere or under review at other journals.

If the article is accepted for peer review, a blind review process will be used in which the identity of the author(s) is unknown to the reviewers. Two to three reviewers will be selected from an international pool of academic experts. The reviewers assigned to the article will comment on the following items:

- * The importance, originality, and timeliness of the policy question
- * Strengths and weaknesses of the study design and data analysis (for research papers) or the policy analysis and commentary (for policy papers)
- * Writing, organization, and presentation
- * The degree to which the findings justify the conclusion
- * The relevance, usefulness, and comprehensibility of the article for the Journal's target audience in government, industry, and academia

The Journal's editors will decide whether to accept or reject an article for review within five (5) business days of submission and will notify the author(s) of their initial decision. The peer review process will be completed in three (3) weeks. The comments and recommendations of the peer reviewers will be consolidated by the editors, who will announce the decision of "accept as is," "accept with minor revision," "revise and resubmit," or "reject."

Authors will receive the results of the peer review process and the final decision from the editors. In the event of a recommendation to "revise and resubmit," the author will be allowed two (2) weeks to deliver an updated version of the article, which will receive a further review by the journal editors before publication.
