- 1. Background and significance of the problem being addressed (no more than 1 page)
- 2. Research question, study hypotheses, outcomes of interest
- 3. Specific aims
- 4. Conceptual framework
- 5. The intervention that will be evaluated
- 6. Research design, including sample size, target population
- 7. Measurement, data collection or data sources
- 8. Overview of analysis plan
- 9. Internal and external validity
