Tribute to the memory of His Excellency John W. Ashe, President of the sixty-eighth session of the General Assembly

The President, on behalf of the General Assembly, conveyed his condolences to the Government and the people of Antigua and Barbuda and to the bereaved family of His Excellency John W. Ashe.

The General Assembly observed a minute of silence.

The President made a statement.

The Secretary-General made a statement.

Statements were made by the representatives of Bulgaria (on behalf of the Eastern European States), Zambia (on behalf of the African States), Japan (on behalf of the Asia-Pacific States), Barbados (on behalf of the Latin American and Caribbean States), Norway (on behalf of the Western European and other States), Suriname (on behalf of the Caribbean Community) and Antigua and Barbuda.

Elections to fill vacancies in principal organs: election of five non-permanent members of the Security Council [item 112 (a)]

The General Assembly resumed its consideration of sub-item (a) of agenda item 112.

The President drew the attention of the Assembly to the letter from the representative of Norway (as Chair of the Western European and other States) contained in document [A/70/964](#).

Since one seat from the Western European and other States remained to be filled, the General Assembly proceeded, in accordance with rule 94 of the rules of procedure, to a sixth round of balloting (second unrestricted ballot).

Having obtained the required two-thirds majority and the largest number of votes, Italy (172 votes) was elected as a non-permanent member of the Security Council for a two-year term of office beginning on 1 January 2017.

The representative of Italy made a statement.

The General Assembly thus concluded its consideration of sub-item (a) of agenda item 112.

The Vice-President (Switzerland) informed the Council that, in accordance with Council resolution 2000/22, the President has appointed the following eight members to the Permanent Forum for a three-year term beginning on 1 January 2017: Ms. Mariam Wallet Aboubakrine (Mali); Mr. Phoolman Chaudhary (Nepal); Ms. Terri Henry (United States of America); Mr. Elifuhara Laltaika (United Republic of Tanzania); Mr. Les Malezer (Australia); Ms. Ann Nuorgam (Finland); Ms. Lourdes Tiban Guala (Ecuador); and Mr. Dimitri Zaitcev (Russian Federation).

Special economic, humanitarian and disaster relief assistance [item 9]

The Council resumed its consideration of the agenda item.

General discussion

The representatives of the United Nations Mine Action Service, World Health Organization, United Nations Children's Fund, Food and Agriculture Organization of the United Nations, United Nations High Commissioner for Refugees, International Labour Organization and the United Nations Educational, Scientific and Cultural Organization also made statements.

The Council thus concluded its general discussion of the agenda item.
