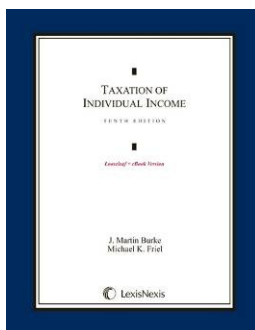

Return Information:

Current Editions = Bookstores may return overstock of new, unmarked, and undamaged books at any time during the life of the current edition. The original invoices must be included and returned with the shipment.

Old Editions = Bookstores have 12 months from the publication date of a new edition to return overstock of new, unmarked, and undamaged copies of the prior edition, with the accompanying, original invoice. To spare you the cost of unnecessary shipping weight, if you are returning a "softcover" title no longer in the current edition, we will accept the "cover" plus the first 10 pages of the book, along with the original invoice.
