For valuable consideration, receipt and sufficiency of which are hereby acknowledged, Author(s) and The Rocky Mountain Association of Geologists ("RMAG") agree as follows:

Representations

I warrant that I am authorized and empowered to as the Author(s) represents and warrants that:

- (i) The Work is original and has been written by the Author(s);
(ii) The Work has not previously been published elsewhere;
(iii) The Work contains no material, including without limitation text, tables, figures, graphs, drawings, photographs and illustrations, from other copyrighted works for which Author(s) has not already obtained a written consent of the copyright holder (collectively, "Authorized Third Party Material"), and Author(s) will supply such written consents to RMAG upon request; and
(iv) The Work contains no libelous or unlawful statements and does not infringe upon the rights or the privacy of any other person or entity.

Assignment

Author(s) agree to transferring and assigning copyright of the Work(s) to RMAG as a requirement for publication, with the exception of Work that is not subject to copyright.

Author(s) hereby irrevocably assigns and transfers (for U.S. government employees, to the extent assignable or transferable) to RMAG and its successors:

- (i) The entire right, title and interest in and to the copyright of the Work (with the exception of Authorized Third Party Material, as set forth below).
(ii) Any registrations and copyright applications relating thereto and any renewals and extensions thereof, and in, and to, all works based upon, derived from or incorporating the Work.

- (iii) All income, royalties, damages, claims and payments now or hereafter due or payable with respect thereto, and in and to all causes of action, either in law or in equity for past, present, or future infringement based on the copyrights, and in and to all rights corresponding to the foregoing throughout the world.
- (iv) This assignment and transfer of copyright includes all material to be published (in any medium) as part of the Work, including but not limited to text, tables, figures, graphs, drawings, photographs and other forms of information included in the Work, with the exception of Authorized Third Party Material, as set forth below.

Author(s) acknowledges that if the Work was prepared by a U.S. government employee as part of the employee's official duties, then it is called a 'U.S. Government work' and there is no copyright to assign or transfer. If the Work was prepared not as part of the government employee's official duties, then it is not a 'U.S. Government work' and the copyright is assigned and transferred as set forth above. If the Work was prepared jointly and any co-author is not a U.S. Government employee, then it is not a 'U.S. Government work' and the copyright is assigned and transferred as set forth above.

### **Author(s) Rights**

Author(s) agrees to execute all papers and to perform such other proper acts as RMAG may deem necessary to secure for RMAG or its designee the rights herein assigned.

### **General Terms and Conditions**

This Agreement shall be construed and interpreted according to the laws of the State of Colorado and shall be binding upon the parties hereto, their heirs, successors, assigns and personal representatives; and references to the Author(s) and to the RMAG shall include their heirs, successors, assigns and personal representatives.

The written provisions contained in this Agreement constitute the sole and entire agreement made between the Author(s) and RMAG concerning this Work, and any amendments to this Agreement shall not be valid unless made in writing and signed by both parties.

Author(s) are required to sign and return this Agreement to RMAG prior to publication. Where the Work is carried out by Author(s) in his or her capacity as an employee of another person or entity ('work made for hire'), an authorized representative of the person or entity that employs Author(s) must sign this Agreement. Each Author(s) of the Work must execute this Agreement. The Author(s) (and, in the case of a 'work made for hire', the signing employer) represents and warrants that he or she has the full power to enter into this Agreement and to make the grants contained herein.
