Medical Withdrawal Classes withdrawal requests older than 6 months may not be eligible for a medical withdrawal. Retroactive withdrawal requests older than 6 months may not be eligible for tuition reimbursement (per the University's Tuition Reimbursement Policy). Exceptions may be granted based on extenuating circumstances. Retroactive withdrawal requests older than seven years will not be considered for tuition reimbursement. Veteran students and students utilizing the GI Bill should contact Veteran Student Services before applying for a medical withdrawal to discuss how it may impact their benefits. International students should contact International Student and Scholar Services before applying for a medical withdrawa to discuss how it may impact their visa.
