Timeframes

- mmons
- 4(a) Issuance of summons
 - Forthwith but at least within 5 days of complaint
- · 4(c) Return
 - Service within 60 days of issuance
- · 4(d) Extension
 - Alias and Pluries/ Endorsement
 - Within 90 days after last issuance

Personal Delivery



- · NC
 - Sheriff of the County
 - Some other person authorized by law
- · Out of state
 - Not a party AND at least 21
 - Anyone duly authorized by law



Mail



- · Certified
 - Receipt at time of mailing
 - Record of delivery
 - Travels as ordinary mail
- · Registered
 - Receipt at time of mailing
 - Signed for each time it changes hands

Kept under lock and key

Mail



- Return Receipt Requested (RRR)
 - Unrestricted
 - Restricted to addressee only



Delivery Service

- 5(£)(3)
- IRS designates 26 U.S.C. 7502(f)(2)
 - Airborne Express
 - DHL Worldwide Express
 - Federal Express
 - UPS



4(j)(1) Natural Person



- · Delivery to person
- Leave with suitable age AND discretion at dwelling house OR usual place of abode
- Registered OR certified AND return receipt requested addressed to party AND delivering to addressee.



4(j)(1) Natural Person



 USPS signature confirmation addressed to party AND delivered to party.



4(j)(2) Natural w/ Disability



- · All ways in 4(j)(1) PLUS
- · Minor
 - Parent OR Guardian having custody OR if none, person having care AND control
 - If still none, appoint a GAL (Rule 17)



4(j)(2) Natural w/ Disability



- If ACTUALLY know under guardianship OF ANY KIND separately serve guardian
- If not ACTUALLY know but person is known to be incompetent to "have charge of affairs - serve GAL (Rule 17)

4(j)(3) State of NC



- Personal delivery to AG OR deputy OR assistant
- Mail registered OR certified, RRR to AG (dep or asst)
- Delivery service addressed to AG (dep or asst) AND delivered to addressee AND obtain delivery receipt

4(j)(4) Agency of State

- Agency, institution, board, commission, bureau, department, division, council, member of Council of State or officer of State govt
- Process agent appointed
 - Name and address filed with AG
 - Personal Delivery
 - Mail registered/certified RRR addressed to agent
 - Delivery service addressed/delivered to agent with delivery receipt
 - If no agent serve AG as in 4(j)(3)



4(j)(5) Counties/Cities

- · City/Town/Village
 - Mayor, City Manager OR Clerk
 - · Personal Delivery
 - · US Mail/Delivery Service
- County
 - County Mgr/Chairman/Clerk OR any member of the Board of Commissioners
 - → Personal Delivery
 - · US Mail/Delivery Service

4(j)(5) Political subdivision/Board of Ed

- Personal delivery to officer OR director OR to agent or attny in fact (authorized by appt or statute)
- · Mail/Delivery Service

If none of the named people can be found in state:



Due diligence/Affidavit Judicial Order Serve AG as in 4(j)(3)

4(j)(6) Corporations

- Officer, director, managing agent OR agent authorized by appt or law
 - Personal delivery
 - Mail OR Delivery Service

For officer/director/managing agent ONLY can also leave in office with person "apparently" in charge of office



- Any general partner or attny in fact/agent
 - Personal delivery
 - Mail OR Delivery Service
 - Leave copies in office with person "apparently in charge"



4(j1) Publication

- Cannot, with due diligence, be served in person, by mail or delivery service.
- Requires no order prior but must file affidavit on due diligence efforts
- 1x per week for 3 consecutive weeks
- Where party believed to be located
- If unknown, then in county where action pending


4(j1) Publication

- If post office address known (or can be ascertained) then mail immediately prior to first publication a copy of notice of service by publication.
- · Post publication file affidavit
- Newspaper must be qualified for advertising (1-597 and 1-598)
